



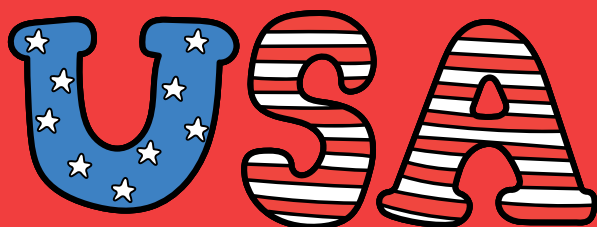

Steve Munisteri has a long history of involvement in political campaigns. He formed a conservative club while a student at Memorial High School. In 1976, he was elected State Vice Chairman for Texas Young Americans for Freedom, was an active volunteer for Ronald Reagan. He also attended the Republican National Convention. He has worked in over 50 campaigns in a voluntary capacity.

In 1999, Steve Munisteri spent time in Iowa working on the George W. Bush presidential campaign in the Iowa straw poll, and then went on to spend a month in California running a Bush campaign office in San Fernando. In 2004, he was part of the Bush legal response team in Ohio during that year's presidential race.

Steve Munisteri served as chairman of the Republican Party of Texas from 2010-2015. In 2017, President Donald Trump appointed him to the White House as Deputy Assistant to the President and Principal Deputy Director of the Office of Public Liaison. He left the White House in 2019 to work on Senator John Cornyn's 2020 Campaign.

In December 2020, Steve Munisteri joined the office of Governor Greg Abbott as senior adviser and policy director.

He will tell us about his experiences working in President Trump's White House and will discuss Governor Abbott's Legislative priorities for this Legislative session.
