LETTER FROM OUR *President*

When we hold our August 25 MCRW General Meeting, we will only be 77 days until the important November 8 General Election. That means that we will have a busy few months ahead of us. You will be needed to work to get our Republican candidates elected.

The MCRW Board of Directors is committed to working toward the goal of getting all Republican candidates elected. But we have decided that we will be dedicated to working on our Associate Member Jay Wright's campaign to be elected to the 9th Court of Appeals. We will be signing our members up to work at the polls for him. We ask that you be as generous with your time as possible.

I recently attended the Texas Federation of Republican Women Board of Directors meeting and learned that TFRW members have been very active political. Since the beginning of the year, TFRW members have volunteered 1,582,922 political activities hours. If members were paid at the minimum wage rate, that would be \$11,476,184.50 worth of work. Well done!

Thank you to all of you who have been reporting your volunteer hours. You are proving that MCRW members have been very busy. Unfortunately, many of you have not been submitting your hours to us. In this newsletter, you will find a partial checklist of activities that count as volunteer hours. Take a look at that list and keep track of activities that you do. And remember to report those hours to us quarterly.

River Plantation Golf Club has notified us that the cost of our meals has increased to \$25 per plate. The cost to

our members will be \$25 if paying by cash or check. The cost of payment by credit card will have to increase to \$27.42 so that we may recover credit card fees. I am sure you have all noticed how the cost of food items has increased at the grocery store. River Plantation has had increased food costs, but also has had to recoup the increased costs of linen rental. After checking the lunch costs at other Republican Women's Clubs in the area, I think we are still receiving good value for our fees.

On July 28, the United States House of Representatives unveiled Congressman Kevin Brady's official portrait in the House Ways and Means Room. Several MCRW members attended the event. In addition to the portrait unveiling ceremony, Congressman Brady's office provided guests with tickets to the Congressional Baseball game and to a party after the game. Guests were also given red shirts to wear to the game and baseball hats. I enjoyed the entire day—well not the little while when it rained during the baseball game. Many Congressmen attended the portrait unveiling and had wonderful things to say about Congressman Brady. As you know, Congressman Kevin Brady is retiring after this year. His district has been divided into 2 sections. District 8 will hopefully be represented by Marcus Luttrell and District 2 will hopefully be represented by Congressman Dan Crenshaw. We will all have to cast our votes for our Republican candidates on November 8.

I look forward to seeing you at our August 25 meeting.

June Meeting

GENERAL MEETING MINUTES MONTGOMERY COUNTY REPUBLICAN WOMEN River Plantation Golf Club June 23, 2022

President Alice Melancon called the meeting to order at 11:30 a.m. with 50 members and 10 guests present. After the PRAYER led by Virginia Miller (Chaplain) and PLEDGES to our flags led by Sarah Kasprzak, Alice welcomed everyone. She recognized elected officials, candidates for office and other guests. The May meeting MINUTES were approved as printed. The TREASURER'S REPORT was approved; it will be filed for financial review.

In the PRESIDENT'S COMMENTS, Alice noted that, besides giving donations to Republican candidates who have opponents in the November election, MCRW is making monetary donations to the Hispanic Conservatives of Montgomery County, to God's Garage, to Alexandra del Moral Mealer running for Harris County Judge, to

the MC Sheriff's Department and to three high school students for college scholarships. She thanked everyone who supported our biennial fundraiser last October so that we could make these funds available. Alice stressed that we must show unity and support for our Republican candidates in the November election.

In COMMITTEE REPORTS, Barbara Eddleman (Membership) stated that we have 115 full members, 60 associate members, and one youth affiliate member. Concerning Caring for America projects, Alice reported that the CISD Rainbow Room (to which MCRW has made donations) helps approximately 600 youths per month. Our club is also supporting (with gift cards) a family who have escaped the ravages of the country of Ukraine and are settling in our area.

Concerning Americanism, Virginia Miller presented a paper by some concerned graduates of West Point on the disturbing rogue conduct by the administration of West Point which rejects adherence to the longtime principles of that Academy, eroding the ethical education and character development of today's cadets. Alice reminded members about our Call to Action concerning the "Keep Nine Amendment" before the Congress by calling our U.S. Representatives from Texas and urging them to support this amendment to keep nine justices on our U.S. Supreme Court. Pearl Maggio (Political Activities) urged members to note the additional volunteer hours which may be reported to TFRW and to get all volunteer hours in to her by the end of each month. Kim Bailey has in her possession extra printed club directories available

for \$5 each. At this meeting young Republicans in our community were recognized. Alice asked those young people present to introduce themselves and tell where they attend school. MCRW is encouraging more young people to join our club.

In UNFINISHED BUSINESS, Alice noted that Steve Toth is giving his MCRW donation to the MC Sheriff's Department to be used for tactical equipment for emergency shooter situations. Alice personally made an additional donation to the Sheriff's Department to help them obtain a new canine for use in their investigations. Also, Alice announced that our three \$1000 scholarship winners are Isabella Carlin of The Woodlands College Park High School, Anna Clair Holleman of The Woodlands High School, and Candice Perdue of Grand Oaks High School. Candice was present at the meeting to receive her scholarship. All three young ladies have outstanding resumes and are very deserving of these scholarships. We are proud to recognize them and their

accomplishments.

In NEW BUSINESS, Alice noted that our CHAT meeting on June 28th will be at the Kasprzak home at 27 East Grand Regency Circle in The Woodlands at 6:30 p.m. to watch the movie "2000 Mules" concerning election fraud in the U.S. Those planning to attend must RSVP to Alice (mcrw.alice@gmail.com) by 4:00 p.m. on June 27th. In addition, Alice announced that our two honorees for the Tribute to Women Dinner (Sept. 17 in Georgetown) are Barbara Eddleman and Lindsey Kasprzak. The

Nominating Committee to select a slate of officers for next year was elected by paper ballot. They are Suzanne Adams, Amy Byers, Virginia Miller, Julia Morton, and Marisa Rummell. Alternates are Stacey Evans and Lindsey Kasprzak.

State Representative Steve Toth of HD15 in Texas was our PROGRAM Keynote Speaker. He gave a very compelling talk

on legislation as related to education in our Texas schools. He stated that SB 393 outlaws the teaching of Critical Race Theory as part of the school curriculum; however, he told us that school districts are presenting supplemental information to teach that theory and also allowing other related activities in our Texas schools. Representative Toth will introduce HB 3979 which will outlaw CRT in Texas schools in any manner.

ASSAULT ON THE FOURTH AMENDMENT TO THE U.S. CONSTITUTION

This week, we are witnessing an unprecedented, truly unbelievable assault on the rights of an American citizen, one Donald J. Trump. In the late afternoon of August 8, the FBI raided the former President's private home in Mar-a-Lago, in West Palm Beach, Florida. Eric Trump has stated that "20 cars and 30 agents" arrived with a search warrant, broke into the home safe, and removed some fifteen boxes of documents from the Trump home.

Never in our history has the home of a former U.S. President been subjected to an FBI search. While the Biden White House has denied any prior knowledge of the search warrant and raid, it is hard to imagine that such an act could happen without the approval of the sitting president.

It appears this action may well have been a violation of President Trump's rights under the 4th Amendment of the United States Constitution. It is important to know and understand exactly what our 4th Amendment means for every American citizen.

As with all of the first ten amendments, it is part of the Bill of Rights. It prohibits unreasonable search and seizure by the government, by setting requirements for the issuance of search warrants. Warrants must:

- Be issued by a judge or magistrate,
- Be justified by probable cause,
- Be supported by an oath or affirmation, and

- Particularly describe both the Place to be searched, and the Person or Thing to be seized. This means that the warrant must list all items the government is searching for, and wishes to seize.

The 4th Amendment was introduced in Congress in 1789 by James Madison, submitted to the States for ratification in the same year, and officially became part of the U.S. Constitution on March 1, 1792.

There was little significant case law regarding the 4th Amendment prior to the 20th Century. The case law since that time has dealt with three main issues:

1. What government activities are deemed to be "searches and seizures",
2. What constitutes "probable cause" to justify a warrant for searches and seizures, and
3. How to address violations of 4th Amendment rights.

One way in which violations of the 4th Amendment is enforced is through the "exclusionary rule". This rule was established in the 1914 case, *Weeks v. United States*.

The Exclusionary Rule comes up very often, when a search and seizure has occurred, as a challenge to the constitutionality of the search. If the judge presiding over the case determines that a search and/or seizure was in violation of the 4th Amendment, the judge can exclude evidence obtained during the search. Evidence resulting from a violation is generally inadmissible in

criminal trials. This would include items seized during the search, but can also include evidence developed later, using the items seized. This is known as "fruit from the poisonous tree".

As more facts become known about the Mar-a-Lago FBI raid, we will find out whether it was a legitimate search and seizure, or another blatant abuse of power by the Biden administration for political gain. At this point, it appears to be a sequel to the long-running disastrous Russian collusion hoax by the corrupt Democrat party. I believe they know the "Red Wave" is coming in November, and are totally desperate to discredit Trump. I also believe this will backfire, just like the Coyote's many attempts to catch the Roadrunner.

Most frightening is the realization that our current administration is willing to do anything to keep President Trump from running again, and is also willing to suspend all due process guaranteed by our Bill of Rights, for those who support Trump. We currently have about 250 private citizens being held under charges related to the January 6 incidents at the Capitol. Most if not all have been denied due process to some extent. Ashli Babbitt was murdered by a Capitol Police officer, who has not been, and likely will not be, charged with her death. If our FBI, CIA, and Washington Capitol Police can carry out these and other acts in violation of our bill of rights, even against the 45th President, no private citizen is safe.

Legislation

On Sunday, August 7th, the U.S. Senate passed the Inflation Reduction Act. The vote was evenly split 50-50, and the tie was broken by Vice President Kamala Harris. This bill, in reality, does not reduce inflation but provides for massive spending

for global warming issues - around \$370 billion to reduce greenhouse gas emissions. The bill also raises taxes on larger corporations and provides for the hiring of 87,000 new IRS employees.

The bill is soon to go to the U.S.

House of Representatives. Please contact as many representatives as possible and urge them to vote no on this massive spending bill which does nothing to reduce inflation.
