





Key Legislation Passed

Topic & Summary

- Redistricting New congressional maps favor GOP; legal challenges anticipated
- Abortion Pills HB 7 bans manufacture/distribution; civil enforcement; medical exceptions
- Restroom Policy SB 8 mandates sex-based designations in public restrooms
- Camp Safety SB 1 enforces floodplain standards for youth camps post-July 4 disaster
- Education Testing HB 8 replaces STAAR with "Student Success Tool"; rollout by 2027–28
- Quorum Penalties New House rules penalize future walkouts with fines and budget cuts

X Major Bills That Failed

Topic & Outcome


- Property Tax Relief SB 10 stalled due to narrow scope and House opposition
- Hemp/THC Regulation SB 6 failed; House declined to advance prohibition efforts
- Police Records HB 15 passed both chambers but died in reconciliation
- Election Reforms Same-day registration ban and AG authority restoration not enacted
- Lobbying Ban Taxpayer-funded lobbying prohibition failed to pass

What's Next:

- Governor has 20 days to sign, or veto passed bills
- Unresolved issues may return in a future special session or wait until 2027

AUGUST MEETING MINUTES: PEARL MAGGIO

MCRW GENERAL MEETING AUGUST 28, 2025, RIVER PLANTATION GOLF CLUB

President Barbara Eddleman called the meeting to order at 11:33 a.m. Kaye Stone gave the opening prayer and led the pledges to the American and Texas flags. Elected officials, candidates, and guests were introduced. President Eddleman reminded members of the Campaign Institute Leadership Training to be held on September 12, 2025. She reported that we have 11 delegates planning to attend the TFRW Convention in San Antonio. Virginia Miller will be attending the NFRW Convention in Orlando, Florida. The minutes of the June 26, 2025, general meeting were approved; the treasurer's report was approved and will be filed as presented.

COMMITTEE REPORTS

- Membership chair Suzanne Adams reported that there are 114 primary members, 55 associate members, and 2 junior affiliates.
- Pearl Maggio announced that 12,546 campaign hours were submitted to TFRW for the third quarter. She reminded all to keep track of their hours for the next submission at the end of October.
- Karen Callanan gave the legislative report which included the redistricting debate in the special session
- of the Texas Legislature. She also reported on the Camp Mystic tragedy response and the nutrition legislation which included remarks from Robert F. Kennedy, Jr.
- Fund Raiser chair Alice Melancon reported that tickets for September 18, 2025, are still available. Two teams will participate in the Political Feud. "The Badge, Gavel and File" will be competing with the "Bench and the Bill." She asked that tickets be purchased by September 10, and that the auctions items be delivered to Pearl Maggio no later than September 15.
- Program Chair Alice Melancon announced that Nick Adams will be the speaker for the October 30, 2025, meeting. There is no November meeting; the Fisher House will present the December meeting.
- Alice then introduced our speaker Bryan Christ who presented an informative program on Artificial Intelligence. Bryan spoke of the risks and reality of AI, how it works, the levels of AI and the generational changes it has and will cause. He pointed out the inevitable changes of AI, its predictions and safety and what we should do. A question-and-answer period followed.
- Kathy Rickli and Betty Byrd gave out the door prizes.

There was no further business and the meeting adjourned at 1:19 p.m.
