## WOKE ATTACK ON MATH: IT WOULD BE A PARODY IF IT WASN'T SO DEADLY

It sounds like a Saturday Night Live skit.

The falsehood that math is racist has gained momentum. Ratcheting up the dialectic, a recent study funded by the Gates Foundation asks administrators to “examine how white supremacy impacts student outcomes” in math. The report condemns a focus on getting the right answer, permitting gifted students to take advanced courses, seeing mistakes as failure, and control of the classroom by the teacher. Following on, the California Department of Education issued a Mathematics Framework. The Framework rejects “natu-

ral gifts and talents,” calls for de-emphasizing calculus and eliminating classes for gifted children, and directs teachers to use math for political discussions about “marginalized communities,” rather than to seek methods or answers.

According to the National Center for Education Statistics, nearly four out of five black and Hispanic eighth graders are not proficient in math. The absurdity that the correct method and answer is white supremacy, rather than people supremacy, is belied by common sense and the lives and tens of billions of dollars lost to math errors. Without math, none of us can compute our bills or taxes, use a recipe, purchase a rug, or compute a tip. Without math, hundreds of billions of dollars can be lost. And people die.

Math is not racial, or racist. There is only math. If we pretend there are no gifted children and cease requir-

ing correct answers, then the data might change – but not the facts. We can never solve our racial or social problems by sweeping them under the rug, or with vituperative sophistry. We need to help disadvantaged minority students learn and embrace math, with rigor, proper methods, and correct answers. The alternative is unimaginably bad.

## “REAGAN AND TRUMP VS. CARTER AND BIDEN”

Ronald Reagan's birthday is February 6, and he would have been 111 in 2022. He took office as President of the United States in January of 1981. We must remember Reagan and Trump's optimism and energy as we approach the 2022 mid-term elections in November. Republicans must be united behind every conservative candidate in order to retake the House and the Senate. In closing, I would remind you all of one of my favorite quotes, by Edmund Burke, who has been called the “First Modern Conservative”. He said, “The only thing necessary for the triumph of evil is for good men to do nothing”. “Good men” and “good women” have “done nothing” for much too long. The massive voter fraud across our nation in 2020 is our call to arms. We must do all we can this year, to ensure the election of strong conservatives, in Texas, and across our nation. 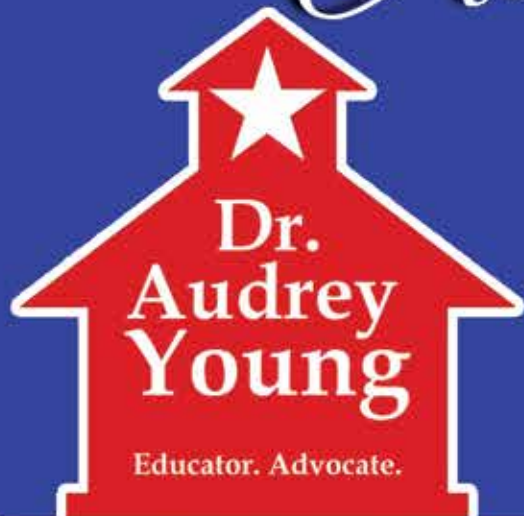
